# GGC Board Allocates 2015 Income and announces payment to retire equity credit

On February 3, 2016, after review of the 2015 end of year financial and income statements, the Board of Directors allocated income of **\$6,899,959** to the members of Golden Growers Cooperative. This allocation is equal to **\$44.54 cents per bushel**. The Board also approved the retirement of a portion of allocated equity credit in an amount of **\$.20 per patronized bushel**.

## **Golden Growers K-1 Tax Forms**

Every year we receive calls from members wondering when they will be receiving their Schedule K-1 tax forms. At the time you receive this newsletter, the K-1s should be ready to be placed in the mail directly from our accountant, Eide Bailly. Unlike 1099s, the process to issue K-1s require Golden Growers to close our yearly financial records, initiate our annual audit, and complete our federal and state tax returns. Although the IRS deadline to issue K-1s is March 15th, we pride ourselves on getting through these required steps as quickly as possible, especially because of the deadline farmers face to file their taxes.

For those of you who winter elsewhere and have your mail forwarded, your K-1s are normally returned to the office. If we have your forwarding address, we will send them along. We also accommodate GGC members who have requested in advance that their K-1s be sent to them electronically or to their tax preparer directly. If you have not provided forwarding information for your K-1, please inform our office of your address, email address, and/or tax preparer so we can meet your tax filing deadlines.

### ND Income Tax Withholding applies to ALL non-ND residents and 'passthrough tax entities'

Due to a change in North Dakota tax law, Golden Growers is required to withhold income tax on the share of income allocated to members who are nonresident Individuals and 'passthrough entities'. Nonresident pass through entities are defined as S-Corporations, LLCs/partnerships, and trusts that do not have a commercial domicile within the state of North Dakota. This means that ND withholding will apply on a larger number of members than in prior years.

February distribution checks will reflect this change in law.
