Dear Golden Growers Member:

For 2017, Golden Growers had net taxable income of **\$8,276,784** which must be allocated to our members in proportion to their patronage during the year. Accordingly, the Board of Directors has declared an allocation of **\$0.5343 per bushel delivered in 2017.** An "allocation" is your share of the taxable income, it is NOT a cash distribution. The IRS Schedule K-1 you received in the mail indicated the amount of your 2017 allocation. You are responsible for any tax liability on your share of the allocation. This allocation is in the form of equity credits.

**The Board also approved a cash distribution of \$0.161 per delivered bushel**, or 30% of the allocation. A check for that amount is enclosed. This distribution is a partial retirement of the calendar year 2017 equity credits, and is not typically taxable.

If you delivered corn in 2017 by Method A (Direct Delivery), you have already received a check for \$0.05 for each bushel delivered. This was the Incentive Payment you earned for 2017 and it will have a different tax effect than the distribution.

If you delivered corn in 2017 by Method B (Agency Delivery), you will note that \$0.02 has been deducted from your distribution for each bushel delivered. This is the Agency Fee for 2017, and it also will have a different tax effect than the distribution.

*Note:* Members who transferred Units paid the agency fee (Method B) during the transfer process. Agency fees on transferred units not deducted from this distribution. Further, allocations of income, reflected on the Schedule K-1, were issued to the Member who transferred Units effective in 2017.

If you are an individual member or a 'passthrough' tax entity and do not reside in North Dakota, state law requires GGC to withhold 2.9% of your taxable income (reported on K-1) for nonresident state income tax.
